Purpose of report

1. To provide the publication schemes (public authorities) performance report 2023-24 as required by the Governance Reporting Framework, and to provide assurance that management of publication scheme adoptions is meeting the key performance indicators set out in the Performance and Quality Framework.

Executive summary

3. The key performance indicators for publication schemes for new bodies 2023-24 are:

*Set at the point of publication scheme file creation, related to commencement date or the date on which we become aware of the authority (usually within three months of either of these points)

4. This year, we haven't had a large tranche of new bodies coming under the scope e.g. RSLs. The due date is nearly always defined by the commencement date, but in some other cases where we alerted to, or discover the creation of a new body (usually post 'commencement' or founding), the 'due date' will be defined on a case-by-case basis taking all circumstances into account.



2023-24 Publication Scheme Notifications

5. Two authorities notified the Commissioner of their adoption of a publication scheme in 2023-24

*Caledonian Sleeper was set up by SERCO at short notice hence the "due date" took into account the particular circumstances involved.

Other Publication Scheme work in 2024

- (i) The Scottish Pubs Code Adjudicator is a new statutory body established by the Tied Pubs (Scotland) Act 2021. The "go live" date was anticipated in 2023 and work began to support this new body with its Publication Scheme duty under FOISA. The founding legislation was subject to legal challenge through the courts, delaying the "go live" date and impacting on notification of a new Publication Scheme. Work is ongoing but as things currently stand, the Scottish Pubs Code Adjudicator (Duty to Publish Certain Information) Regulations 2024 will make the Adjudicator subject to a duty to publish information under the Public Services Reform (Scotland) Act 2010 (by adding the Adjudicator to the public bodies listed in schedule 8 of the Public Services Reform (Scotland) Act 2010. This is not yet complete but is expected to be in place in time for the regulatory regime coming into force on 7 October 2024, by which we need to ensure we have both received notification of its Publication Scheme, and the Commissioner has given his approval.
- (ii) P&I Team also undertook Publication Scheme Notification work with National Smart Ticketing Board (the Board) for an expected due date of 1 April 2024. On 8 March 2024 this new body informed us that the Board would be set up in such a way that it would not meet the definition in FOISA of a Scottish Public Authority in it's own right. Instead, the Board, and the National Smart Ticketing function, would remain part of Transport Scotland's remit. Given this change of set-up, we no longer required Publication Scheme notification.
